## Sub: - Intimation regarding lapse of warrants and forfeiture of upfront payment

Dear Sir/ Madam,

Pursuant to the provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, and in continuation to our earlier intimations regarding the allotment of warrants, we hereby inform you that the Company had allotted 1730000 warrants at a face value of ₹10/- each with a premium of ₹562/- per share on 22<sup>nd</sup> April, 2024 on a preferential basis that were originally proposed for conversion now correspond to 17300000 convertible warrants of face value ₹1/- each with a premium of ₹56.2/- per share, entitling the warrant holders to apply for and be allotted equivalent number of equity shares of the Company within a period of 18 months from the date of allotment i.e. 22<sup>nd</sup> April, 2024. The last date for exercising the option for conversion of warrants into equity shares was 21<sup>st</sup> October, 2025. Since the allottees as enlisted in the attached Annexure -1 have not exercised the option of conversion within the stipulated period, the said warrants have lapsed with effect from 21<sup>st</sup> October, 2025. Accordingly, in terms of SEBI (Issue of Capital and Disclosure Requirement) Regulations, 2018, the upfront amount of Rs. 14,01,40,000/- i.e. 25% of the issue price received at the time of allotment of warrants stands forfeited by the Company.
